Your use of www.luxurytravelbyginni.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference. Our obligations to you are to make travel bookings on your behalf and to arrange relevant contracts between you and the travel service suppliers. Luxury Travel by Ginny has no responsibility for these services, nor does it have the authority to make any warranty or representation regarding these travel service suppliers. All such entities are independent companies and not part of Luxury Travel by Ginny in any way. A request cannot be guaranteed. In addition, Luxury Travel by Ginny takes no responsibility or liability for any injuries or damages sustained by clients due to anything the supplier does or does not do that affects you as clients. All bookings are subject to the terms, conditions, and limitations of liability imposed by these travel service suppliers. 2. Booking Travel:

3. Booking Changes:

If you decide to make changes in a booking Luxury Travel by Ginny will try to help you but any changes in booking may not be possible.

4. Pricing:

Prices may increase prior to the time you make full payment but are not subject to increase after final payment except for government-imposed taxes or fees. By making your booking, you expressly acknowledge your acceptance of these conditions as being applicable to your booking.

5. Cancellations:

Most travel bookings are non-refundable and cancelled bookings will incur penalties which can be up to 100% of the cost of the trip regardless of whether the travel has begun or not. All cancellations must be sent in writing to Luxury Travel by Ginny. Cancellation of travel may result in penalties preventing you from receiving a refund or other compensation. Any unused portion of a travel booking will not be refunded due the contract commitments and pricing requirements that are required of Luxury Travel by Ginny. Groups that fall below the appropriate number of persons may be cancelled. You agree to hold Luxury Travel by Ginny harmless for any amount or fee that is charged for any cancellation.

6. Final Payment:

For any travel you are required to make a deposit. Final payment is required at least 60 days before travel and often final payment is due 90 days before your trip. Luxury

Travel by Ginny requires payment two weeks before the final payment date. Failure to make final payment will result in cancellation of the travel arrangements. If it is necessary to cancel travel arrangements this request must be made in writing to Luxury Travel by Ginny.

7. Credit Cards:

If any service providers are unable to provide services you have contracted for, your recourse is to get a refund from the supplier and not Luxury Travel by Ginny.
